The routes are 250+ miles long and Law Enforcement Officers, and Survivors nationwide make this arduous journey pedaling to honor the service and sacrifice of their law enforcement colleagues and family members who have died in the line of duty. Our membership is also comprised of logistical support including motor escorts, medical staff, food, hotel, and transportation support team members who support each of these riders during the three day journey. The officers and survivors also ride to raise awareness of and provide monetary support to **Concerns of Police Survivors® (C.O.P.S.)** and **Officer Down Memorial Page® (O.D.M.P.)**.
